SCHOOL MANAGED iPad PROGRAM PARTICIPATION AGREEMENT (PLEASE TICK)

- ☐ I have read and understood the School Managed iPad Program Participation Agreement and agree to abide by the guidelines and agree to pay the participation fee of \$600 either up front or via a pre-payment plan with deposit agreed to with the school (minimum \$200 to be paid by February each year in program)

RESPONSIBLE USE AGREEMENT FORM

The goal is to ensure the safe and responsible use of services available to students through the provision of clear rules and guidelines. The student must understand that the right to use a device at school is conditional on the student abiding by the Participation Agreement. The device is primarily provided for an educational purpose. Responsible use requires that the student follows the rules for the use of the device in the Beenleigh State High School Student Code of Conduct.

BREACH OF RESPONSIBLE USE

Students will be held responsible for any actions caused by other persons using their account with the student's knowledge. The school reserves the right to limit access of devices to the intranet, internet, email, or other network facilities to ensure the security of the network and to provide a safe environment for all. The misuse of devices may result in disciplinary action which is not limited to the withdrawal of access to school services.
